ORDER:-

In the reference 1<sup>st</sup> and 2<sup>nd</sup> read above, the Vice Chairman & Managing Director, Andhra Pradesh Co-operative Oilseeds Growers' Federation Ltd. has reported that the Kharif-2015 Groundnut crop arrivals and opening of procurement centers for implementation of PSS operations by appointing M/s Andhra Pradesh Co-operative Oilseeds Growers' Federation Ltd, as State Level Nodal Agency for the activity. In order to ground the activity, the Vice Chairman & Managing Director, Andhra Pradesh Co-operative Oilseeds Growers' Federation Ltd, has requested the Government to arrange to release Rs.10.00 Crores to Andhra Pradesh Co-operative Oilseeds Growers' Federation Ltd, from the Agricultural Marketing Department and exemption from payment of Market Fee for the Groundnut produce procured under Price Support Scheme, Kharif-2015 and the same has been informed to the Joint Secretary (Co-Op) Dept of Agriculture, GOI, New Delhi as a part of the proposal for implementing Price Support Scheme for Groundnut in Andhra Pradesh.

2. Government, having examined the matter in consultation with the Commissioner & Director of Agricultural Marketing, A.P., Hyderabad hereby accord sanction for an amount of Rs. 05.00 Crores (Rupees Five Crores only) as an advance to Andhra Pradesh Co-operative Oilseeds Growers' Federation Ltd. from the Central Market Fund Funds subject to reimbursement by the Andhra Pradesh Co-operative Oilseeds Growers' Federation Ltd, to start Groundnut procurement operations during Khariff-2015.

3. Government, having examined the matter in consultation with the Commissioner & Director of Agricultural Marketing, A.P., Hyderabad hereby exempt from levy of Market Fee for the Groundnut (In-Shell) produce procured by M/s Andhra Pradesh Co-operative Oilseeds Growers' Federation Ltd. / M/s National Agricultural Cooperative Marketing Federation of India Ltd (NAFED) under Price Support Scheme (PSS) operation during the Marketing Season, Kharif-2015 in Andhra Pradesh.
